- Members must complete registration form.
- Membership is reviewed and subject to approval based upon certain criteria.
 - Members should, preferably, have economic need of aid for services provided.
 - Members must be unsigned artist. Artist signed to label and/or management agreements do not qualify for services.
 - Members must aspire to create works solely within the genre of Christian Music.
- Approved members will be given membership ID#
- Members will have full access to features of the site, including access to service provider listings.
- Members are allotted unlimited access to educational and ministry tools.
- Members are given specifically-detailed allotments to the attainment and usage of services offered in service provider listings included in the Free and Grant-Provided Services Sections.
 - Allotments for service provider types are as follows:
 - Production
 - Free/Grant-Provided
 - 1 listing per month
 - Recording
 - Free/Grant-Provided
 - 1 listing per year
 - Engineering/Mixing
 - Free/Grant-Provided
 - 1 listing per 6 months
 - Engineering/Mastering
 - Free/Grant-Provided
 - 1 listing per 6 months
 - Videography
 - Free/Grant-Provided
 - 1 listing per year
 - Photography
 - Free/Grant-Provided
 - 1 listing per year
 - Print Media
 - Free/Grant-Provided
 - 1 listing per 6 months
 - Graphic Design
 - Free/Grant-Provided
 - 1 listing per 6 months
 - Usage of Discounted services are unlimited.

- Grant-Provided services are offered upon Grant-fund availability.
- All listing types (Free, Grant-Provided, and Discounted) require the submission of Service Listing- Member Request Form.
 - All forms are reviewed and subject to approval.
 - A separate form is required for each individual listing.
- Upon approval, FCMAS will facilitate initial correspondence between member and service provider.
 - For Discounted Listings, an invoice requesting payment will be emailed to member, and payment must be made prior to start of arrangement.
- Service arrangement agreement must be signed by both parties prior to initiation of services
- FCMAS is not responsible for the completion of services.
 - Member payment for Discounted Listings will be refunded if incompleteness of services is due to fault of service provider.
- Failure to fulfill terms of agreement from either member or service provider can result in site access and membership revocation.
- Arrangements are considered legally binding, thus subject to legal resolution.
- Members will receive newsletters and periodically-distributed resources and tools, directly to the email address listed on membership registration.
 - Members can opt out of this service.
- Membership information will NOT be shared with 3rd parties, unless needed to initiate a service listing arrangement.
 - Service providers are considered 3rd party.
 - Member contact info will be provided to service provider at the arrangement of service listing initiation of services.
 - Service-providers will not be allowed to contact members without the expressed permission of the member.
